**Minimum wages in

**International Workshop
7 – 8 November 2024 Berlin**

Fundamental changes are currently taking place in labour markets. Labour shortages and a changing labour supply are increasingly becoming determining factors. These developments can be seen in the labour markets of almost all western industrialized countries. The workshop will address the question of what effects minimum wages have under these changed conditions. Among other things, the effects of minimum wages on the labour supply of certain demographic groups, such as labour market entrants or older employees, and the effects of minimum wages on migration flows and the labour market integration of immigrants will be central themes. The inter-relationship between minimum wages and collective bargaining will be another focus. The workshop will present research findings from Germany, other EU member states, the USA and the United Kingdom.

The workshop will be held in English with simultaneous translation into German.

In Arbeitsmärkten finden aktuell grundlegende Veränderungen statt. Arbeitskräfteknappheit und ein verändertes Arbeitsangebot entwickeln sich zunehmend zu bestimmenden Faktoren. Diese Entwicklungen zeigen sich in den Arbeitsmärkten von annähernd allen westlichen Industrieländern. Welche Effekte Mindestlöhne unter den veränderten Rahmenbedingungen entfalten, steht als Kernfrage im Mittelpunkt des Workshops. Dabei werden unter anderem Effekte von Mindestlöhnen auf das Arbeitsangebot von bestimmten demographischen Gruppen, wie z.B. Arbeitsmarkteinsteigern oder älteren Beschäftigten, und Auswirkungen von Mindestlöhnen auf Migrationsströme und die Arbeitsmarktintegration von Einwanderern beleuchtet. Das Wechselsehältnis von Mindestlöhnen und Tarifgeschehen steht ebenfalls im Blickpunkt. Der Workshop präsentiert Forschungsergebnisse aus Deutschland, anderen EU-Mitgliedstaaten, den USA und dem Vereinigten Königreich.

Der Workshop wird auf Englisch stattfinden. Es wird eine Simultanübersetzung ins Deutsche geben.
